I, Mayur S. Mandlecha, Chartered Accountant in practice, have been appointed as a Scrutinizer by the Board of Directors of "Emerald Leisures Limited", (Formerly known as "Apte Amalgamation Limited") by the Board on 12th August, 2016, for the 82nd Annual General Meeting of the Company, for the purpose of:

The Notice convening the Annual General Meeting along with the statement setting out material facts under Section 102 of the Companies Act, 2013 were sent to shareholders in respect of the below mentioned resolutions to be passed at the Annual General Meeting of the Company.

The Company had availed the remote e-voting facility offered by CDSL for facilitating remote e-voting to the Shareholders of the Company. The Company also provided voting by physical



ballot papers at the venue of the AGM to those members who attended the AGM and who had not voted electronically.

The Shareholders of the Company holding shares of the Company as on the "cut-off" date i.e 19th September, 2016 were entitled to vote on the resolutions as contained in the Notice of the AGM of the Company.

The period for remote e-voting commenced on Monday 26th September, 2016 at 7.00 p.m. to Wednesday 28th September, 2016 till 5.00 p.m.

After the end of the remote e-voting period, I was provided access to details of the members who had opted for e-voting. 
