

- I, S.K. Gupta, Company Secretary in practice, have been appointed as a Scrutinizer by the Board of Directors of Commercial Engineers & Body Builders Co Limited (the 'Company') for the purpose of Scrutinizing the remote e-voting process under the provisions of Section 108 of the Companies Act, 2013 (the Act) read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (Rules) and on poll under the provisions of Section 109 of the Companies Act, 2013 read with Rule 21 of the Companies (Management and Administration) Rules, 2014, in respect of the resolutions contained in the Notice of the Thirty Sixth Annual General Meeting (AGM) of the Members of the Company held on Saturday, the 24th September, 2016 at 3.00 P.M. at Auditorium of U.P. - 3. In respect of remote e-voting process conducted under my supervision, I hereby report as under:-
