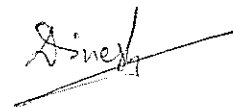
The Chairman replied the queries raised by the shareholders of the Company.

1. Adoption of Financial Statements of the Company for the year ended 31st March, 2016
2. Declaration of Dividend on Equity Shares
3. Appointment of Mr. Nishant Arya (DIN: 00004954), as Director, who were liable to retire by rotation
4. Re-appointment of Auditors and fix their remuneration
5. Authorization of Board of Directors of the Company to borrow money in excess of the aggregate of the paid up share capital and free reserves of the Company

The Chairman further informed that the result of vote casted through remote e-voting system as well as through Ballot Papers shall be displayed on the website of the Company and also on the website of the Agency –'NSDL' within 48 hours.
