Sub.: Intimation of details for E-Voting and Voting at AGM Venue

This is to inform you that in compliance with Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and pursuant to Section 108, 110 and other applicable provisions of the Companies Act, 2013 read with the related Rules, the Company is pleased to provide it's members, the facility to exercise their right to vote by electronic means on all the business to be transacted as set forth in the Notice of the AGM of the Company through the e-voting facility provided by CDSL (Central Depository Services Limited). The detailed instructions for e-voting facility are contained in the Notice of the AGM which has been sent to all the Members.

The details pursuant to the provisions of the Companies Act, 2013 and the Rules are given hereunder:

1. Cut-off date for the purpose of e-voting: 21st September, 2016;
2. Date & time of commencement of e-voting: From 09.00 a.m. on 24th September, 2016;
3. Date & time of end of e-voting: 05.00 p.m. on 27th September, 2016;
E-voting shall not be allowed beyond the said time and date;
4. Persons who have acquired shares and become Members of the Company after dispatch of the Notice of the AGM and holding shares as on the cut-off date i.e. 21st September, 2016 may cast their votes by following instructions and process of e-voting as provided in the Notice of the AGM;
5. A person whose name is recorded in the Register of Members or in the Register of Beneficial Owners maintained by the depositories as on the cut-off date only, shall be entitled to avail the facility of e-voting as well as voting in the AGM;
6. Members may participate in the general meeting even after exercising their right to vote by e-voting but shall not be allowed to vote again in the meeting;
7. The facility for voting through poll paper shall also be made available at the AGM and the Members who have not cast their vote by e-voting shall be able to exercise their right at the AGM. In case if members cast their votes through both the modes, voting done by e-voting shall prevail and vote cast through poll-paper shall be treated as invalid.

You are requested to kindly take the above on record.
