- 1. The Board of Directors of the Company, at its meeting held on 10th August, 2016, has appointed me as the Scrutinizer for conducting the postal ballot voting process (including e-voting) in a fair and transparent manner.

- 2.1 The Company has completed the dispatch of postal ballot forms along with postage prepaid business reply envelope to its Members whose name(s) appeared on the Register of Members/ list of beneficiaries as on 5th August, 2016.
- 2.2 The Company or its Share Transfer Agent has not received any ballot forms up to 5.00 p.m. (IST) on 22nd September, 2016, the last time and date fixed by the Company.
- 2.3 As on the date of this report, no envelopes containing postal ballot forms were received after 22nd September, 2016, 5.00 p.m. (IST).
- 2.4 As on the date of this report, no envelopes containing postal ballot forms were returned undelivered.
- 2.5 I did not find any defaced or mutilated ballot paper.
- 2.6 The E-Voting period was commenced on Wednesday, 24th August, 2016 (9.00 a. m.) and ended on Thursday, 22nd September, 2016 (5.00 p. m.).
- 2.7 I have also received a complete record from Central Depository Systems Limited, the agency appointed for providing and supervising electronic platform, of votes casted through electronic mode upto 5:00 p.m. on 22nd September, 2016. The votes cast were unblocked on 22nd September, 2016 at 5.24 p.m. (IST) in the presence of two witnesses, Ms. Mittal Gori and Mr. Akshay Shah who are not in the employment of the Company.
