The 64th Annual General Meeting of the Company was held at its registered office at 'DIL' Complex, Ghodbunder Road, Majiwada, Thane (West) – 400 610, Maharashtra on Tuesday, September 27, 2016, which commenced at 3.00 p.m. and concluded at 4.00 p.m.

As per the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration Rules) 2014 and Regulation 44(1) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided the facility of remote evoting ('e-voting') to the Members of the Company to enable them to cast their vote electronically on the resolutions proposed in the Notice of the 64th Annual General Meeting (AGM). The e-voting was open from September 24, 2016 (9.00 a.m. IST) to September 26, 2016 (5.00 p.m. IST). The Company also provided facility to vote through ballot form to those Members who do not have access to e-voting facility. The last date for receiving the ballot form was September 26, 2016 (5.00 p.m. IST).

The Board of Directors had appointed Mr. V. N. Deodhar (Membership No. FCS 1880), Proprietor of V. N. Deodhar & Co., Practising Company Secretaries as the Scrutinizer for e-voting and voting through ballot form. The Chairman appointed Mr. V. N. Deodhar as the Scrutinizer for the poll / ballot voting conducted at the AGM. The Scrutinizer has carried out the scrutiny of all the electronic votes (including ballot forms) received up to September 26, 2016 (5.00 p.m. IST) and poll received till conclusion of the AGM and submitted his Report on September 27, 2016.

Deodhar & Co., Company Secretaries having office at 4/3 Radha, 1st Floor, Shastri Hall, Grant Road (West), Mumbai 400007 was appointed as Scrutinizer for the purpose of scrutinizing the E-voting process, Postal Ballot and Physical Ballot Process in a fair and transparent manner for the resolutions to be passed at the 64th Annual General Meeting of the Company held on Tuesday, 27th September, 2016 at 3.00 P. M. at DIL Complex, Ghodbunder Road, Majiwada, Thane (West),400610 and ascertaining the requisite majority on E-voting as well as Postal Ballot and Physical Ballot carried out as per provisions of the Companies Act, 2013 ("the Act") and Sub rule (xi) of Rule 20 of the Companies (Management and Administration) Rule, 2014 and in accordance with Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations,2015. The Company sought approval of Members to the Resolutions via E- Voting, Postal Ballot and Physical Ballot Process:

- The E-voting period commenced at 9.00 a.m. on Saturday, 24th September, 2016 and ended at 5.00 p.m. on Monday, 26th September, 2016. The E-voting module was disabled by CDSL for voting thereafter.
- Voting rights were on the paid-up value of shares registered in the name of the member as on the Cut Off date i.e. 20th September, 2016.
- The Shareholders holding shares as on the "Cut Off" date i.e. 20th September 2016 were entitled to vote on the proposed 6 (Six) Resolutions as mentioned in the Notice of the 64th Annual General Meeting of the Company.



At the venue of the 64th Annual General Meeting of the Company held on 27th September, 2016, the facility to vote through Physical Ballot was provided to facilitate those members present in the meeting and had not participated in the Remote E-voting to record their votes.

After the voting at the Annual General Meeting was concluded the locked Ballot Box was opened in my presence and in presence of two witnesses, as mentioned below, and Ballot papers were diligently scrutinized.
