Summary of Proceeding of the 25th Annual General Meeting

The 25th Annual General Meeting of the Members of Haldyn Glass Limited was held today (i.e. on Thursday, 29 September 2016) at 11.30 A.M. at the Registered Office of the Company at Village Gavsad, Taluka Padra, Dist. Vadodara-391 430, Gujarat. Mr. N.D. Shetty, Executive Chairman, chaired the meeting and welcomed Mr. Tarun Shetty and Mrs. K.J.Udeshi and the members present at the meeting. Chairman to the meeting was assisted by Mr. A.A. Lambay, Company Secretary and Compliance Officer.

The requisite quorum being present, the Chairman called the meeting to order. The Chairman of the meeting has briefed about the objectives for passing of the resolutions.

The Chairman has referred his speech including overview of the financial performance of the Company for the financial year ended 31st March 2016 and also enlighten about overall business and operation and prospect of the Company.
