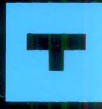

Gist of the proceedings of the Annual General Meeting
Of Thomas Scott (India) Limited held on Thursday, September 29, 2016

The 6th Annual General Meeting of the Members of the Company was held on Thursday, September 29, 2016 at 10.30 a.m. at Maheshwari Bhavan, 603, Jagannath Shankar Seth Road, Mumbai- 400 002.

Mr. Vijay Dattatraya Ajgaonkar chaired the proceedings of the Meeting. Total 50 Members attended the Meeting and out of 50 members, 44 members attended in person and 6 members attended in proxy as per the records of attendance.

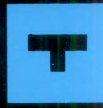
The Chairman gave an overview of the financial performance of the Company for the financial year ended March 31, 2016 and its future outlook.

The Chairman informed the Members that pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had extended the e-voting facility to the Members of the Company in respect of businesses to be transacted at the Annual General Meeting. The e-voting commenced at 9.00 a.m. on Monday, September 26, 2016 and ended at 5.00 p.m. on Wednesday, September 28, 2016. M/s. Kothari H. & Associates, Practicing Company Secretaries was appointed as the Scrutinizer by the Board for scrutinizing the e-voting process.

The Chairman informed the Members that the Company has arranged for a poll on all the 4 resolutions to be passed at the Meeting. Thereafter, all the 4 resolutions were proposed and seconded. On the invitation of the Chairman, members placed their queries, suggestions and appreciation on Company's accounts and businesses, which were replied and appreciated by the Chairman.

Thereafter, the Chairman ordered for a poll to be taken at the meeting and appointed M/s. Kothari H. & Associates Practicing Company Secretaries as the Scrutinizer for the poll process and requested them for an orderly conduct of the voting. The Chairman announced that the combined result of e-voting and the poll will be put on the Company's website.





Resolutions for the following businesses were passed by the members:

ORDINARY BUSINESSES:

1. To consider and adopt the Audited financial statements of the Company for the financial year ended March 31, 2016 and the Reports of Board of Directors & Auditors thereon.
2. To appoint a Director in place of Mr. Purshottam Bang (holding DIN 02544947), who retires by rotation at this Annual General Meeting and being eligible, offers himself for re-appointment.
3. To ratify the appointment of Auditors and fix their remuneration.

SPECIAL BUSINESS:-

4. To approve Related Party Transactions for the period upto March 31, 2019.

The Chairman informed that the e-voting and poll results will be notified to the Stock Exchanges and also uploaded on the Company's website.
