

1. **Rs.209.50 Crores contract for 3 x 800 MW Krishnapatnam APPDCL**

**Project:** The contract is for Water Treatment Plant package for 3 x 800 MW Unit of APPDCL, Krishnapatnam Stage 1 & 2 at Nellore, A.P. The scope of work includes manufacturing, shop inspection & testing, supply, packing & forwarding, erection, testing, commissioning and conducting contract performance guarantee testing of various equipments associated with Pretreatment, Desalination, Post Treatment and Demineralisation. The aggregate treatment capacity of these plants are more than 55 million litres per day (MLD) and these units will be completed over 23 months. The Company will also carry out O&M of these units for a period of 12 months.

The scope includes Design, Build and Operate (DBO) of 45 MLD Capacity Tertiary Treatment Reverse Osmosis (TTRO) Plant at Kodungaiyur including Supply and laying DI Transmission mains for conveyance of Product water to various industries in Manali area, Chennai and subsequent O&M for 15 years.

The contract value of Rs.440 Crores consists of Rs.235 Crores for construction of plant and transmission pipelines and Rs.205 Crores for O&M for subsequent 15 years. Duration of the contract is 24 months for construction and commissioning and 6 months for trial run.
