Pursuant to regulation 30 of the SEBI (Listing Obligations Disclosures Requirement), 2015, In furtherance to our earlier intimation regarding consent by the Board of Directors for development of Private IT Park on June 21, 2016 we wish to inform you that the Company has entered into a Memorandum of agreed terms with M/s. Cliff Conwell LLP (AAB-3912) today i.e. 5th January, 2017.

The salient features of the Memorandum of agreed terms inter alia are as follows:

- GEE Limited and Cliff Conwell LLP shall form an LLP by nominating their designated partners and the LLP ("Proposed LLP") to be named as "GEE Tropical Infrastructure LLP" or any other name as may be available with the Registrar.
- 2. GEE Limited shall transfer Development Rights of its land situated at Plot No. E-1 Plot No. E-1, Road No. 7, Wagle Industrial Estate, Thane (W) 400 604 to the Proposed LLP.
- 3. Ratio of profit and loss of GEE & Cliff shall be 50:50.
- 4. GEE shall bring Development Rights as mentioned above with agreed value at Rs. 69.50 Cr. (Rupees Sixty Nine Crores Fifty Lacs Only) and M/s. Cliff Conwell LLP to introduce equal capital as its contribution in phased manner.
