I, Deepak Gupta, Company Secretary, have been appointed as Scrutinizer by the Board of Directors of PNC Infratech Limited (the Company) for Scrutinizing Postal Ballot voting including voting by electronic means in respect of the passing of resolutions contained in the notice dated December 07, 2016 through Postal Ballot.
