Summary Proceedings of the Annual General Meeting of the Company

The 10th Annual General Meeting ("AGM") of the Members of the Company was held on Friday, September 29th, 2017 at 12.00 P.M. at G-05, China 1, Bandra Kurla complex, Bandra East, Mumbai Maharashtra 400051 and concluded on 1:00 P.M.

Total 31 members attended the Meeting. Four of our Directors of the Company were present at the Meeting, including the Chairman of Audit Committee, Nomination, Remuneration & Compensation Committee and Stakeholder's Relationship Committee were present at the Meeting. The representatives of Statutory Auditors and Secretarial Auditor were also present at the Meeting.

Mr. Akshay Kumar Gurnani Chairman of Board of Directors took the chair and welcomed the members to the Annual General Meeting. Mr. Govind Ram Thawani, Director of the Company, chaired the proceedings in respect of the items of business where Mr. Akshay Kumar Gurnani was deemed to be interested. The requisite quorum being present, the Chairman called the meeting to order.

The Chairman gave an overview of the financial performance of the Company for the financial year ended on March 31, 2017 and given Chairman's speech together with discussing future outlook of the Company. With the permission of the Members, the Notice of the AGM was taken as read.

He further informed the members that the Company extended remote e-voting facility to the Members of the Company in respect of business to be transacted at the Annual General Meeting. The remote e-voting commenced on Tuesday, 26th September 2017 9:00 A.M. and ends on Thursday, 28th September 2017 5:00 P.M. (both inclusive). Ms. Manisha Kalra, Company Secretary in practice, Jaipur was appointed as Scrutinizer by the Board for scrutinizing the remote evoting process.

The Chairman informed the Members who were present at the AGM and had not cast their votes electronically were provided an opportunity to cast their votes through poll arranged on all the Nine (9) resolutions to be passed at the Meeting. All the resolutions were proposed and seconded. The Chairman appointed Ms. Manisha Kalra, Practicing Company Secretary as the Scrutinizer for the polling and requested her for an orderly conduct of the voting. Thereafter, the Chairman announced for poll to be taken at the meeting through Polling Paper. It was further informed that there would be no voting by show of hands.
