The comments communicated in the above SEBI letter refer to inter alia:

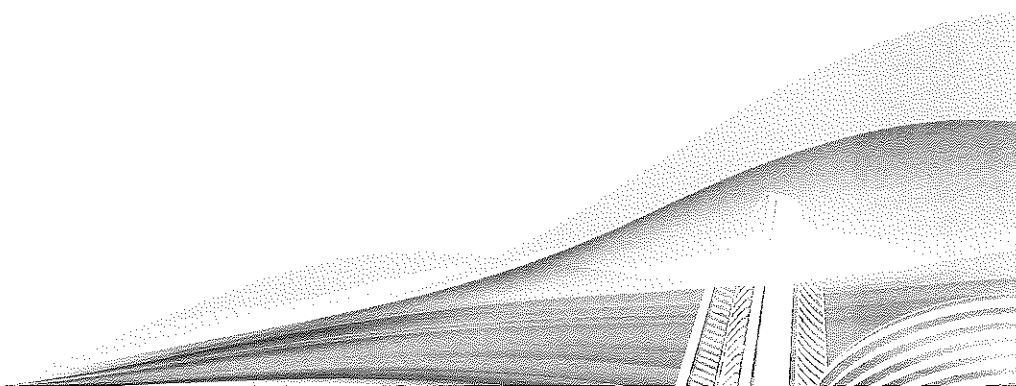


