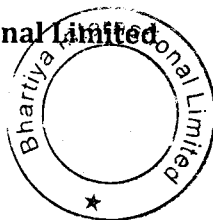

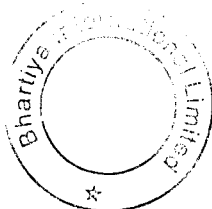
Bhartiya International Limited has received order to supply finished leather to COACH Inc.
