- 7. By this notice, you are hereby called upon to discharge the entire liability as on date and also future interest thereon, at applicable rates, to us as Secured Creditor within 60 days from the date of this notice, failing which the bank shall Act.

Please take notice that in terms of Section 13(13) of the said Act, you shall not after receipt of this Notice, transfer by way of sale, lease or otherwise, any of the secured assets above referred to, without prior written consent of our bank. You are also put on Notice that any contravention of the injunction/restraint as provided under the said Act is an offense.
- 9. This Notice is issued without prejudice to bank's rights contentions and remedies in suit/proceeding before the DRT/Court.
