2. We have not performed an audit and accordingly, we do not express an audit opinion.
3. We did not review the financial statements of the three (3) subsidiaries, whose financial results reflect total revenue of Rs. 2808.42 Lacs as at 30th June 2017. These interim financial statements are reviewed by the management whose report(s) has/have been furnished to us by the management and our opinion on the statement, in so far it's relates to the amounts and disclosures included in respect of these subsidiaries is based solely on the report's of the management.
