The Board of Directors have approved the Scheme of Arrangement (Demerger / Acquisition) ('Scheme') of the Wind Power division of Weizmann Forex Limited with the Company as per Section 230-232 of the Companies Act, 2013 subject to necessary statutory approvals from regulators, Shareholders of the Transferor and Transferee companies, Creditors and the National Company Law Tribunal. Pursuant to the scheme of arrangement Weizmann Forex Ltd would be the transferor company and Karma Energy Ltd would be the resultant / Transferee Company.

Brief details of change in shareholding pattern (if any) of all entities	There will be no change in shareholding pattern of the Transferor Company namely Weizmann Forex Ltd Pursuant to acquisition of the wind power division of Weizmann Forex Ltd by a Scheme of arrangement further equity shares would be issued by the company to the shareholders of Weizmann Forex Ltd as on record date to be decided in due course, as per the share exchange ratio as detailed herein below. No cash consideration would be paid by the Company to Weizmann Forex Ltd or their shareholders.
6.	Whether listing would be sought for the resulting entity.	Yes the further equity shares issued by the company are proposed to be listed on BSE Ltd and National Stock Exchange of India Ltd subject to regulatory approvals.
