
Notes to Financial Results

1. The above unaudited financial results were reviewed by the Audit Committee and thereafter approved and taken on record by the Board of Directors in their meeting held on 14th November, 2017 and the statutory auditor of the Company have conducted a " Limited Review" of the above financial results for the quarter and half year ended 30th September, 2017.
2. The Company is operating under three business segments viz. IT & IT Related, Agri & Food and Investment/Securities/Trading segment. However, in current quarter there is no transaction in other than IT Segment. The Company would provide Segment wise reporting as and when applicable in the sub-sequent quarters.
3. The Company has adopted Indian Accounting Standards ("Ind AS") for the financial year commencing from 1st April, 2017 and above results are prepared in accordance with principles laid down under IND AS 34 as prescribed under section 133 of the Companies Act, 2013 read with the relevant rules issued thereunder and in terms of regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and SEBI Circular CIR/CFD/FAC/62/2016 dated July 05, 2016. The Company has opted to avail the relaxation provided by SEBI in respect of disclosure requirements for corresponding figures of earlier periods.
4. Further, in accordance with the circular, the IND-AS compliant financial results for the corresponding quarter ended 30th September, 2016 has been presented after incorporating the applicable IND AS adjustments. This information has not been subject to any Limited Review or Audit. However, the management has exercised necessary due diligence to ensure that the financial results provide as true and fair view of its affairs.
5. Reconciliation of net profits for the quarter and half year ended 30th September, 2017, as reported under previous GAAP and IND AS is given below:
