New Delhi, 2nd Nov 2017: Lumax Industries Ltd, today inaugurated its 9th lighting manufacturing facility in India at Sanand, Gujarat. The state-of-the-art, automated facility has been setup with an initial capacity of 300,000 car-sets annually, on an area of 7 acres.

The plant was inaugurated by Mr. K Ayukawa, Managing Director, Maruti Suzuki India Limited and Mr. N Aizawa, Managing Director, Suzuki Motor, Gujarat, in the presence of Mr. T Kitano, President, Stanley Electric Co. Ltd., Japan.

The plant was setup in record time of 8 months through the concerted efforts of the team and unstinted support from our partners Stanley, Japan and our esteemed customers – Maruti Suzuki India and Suzuki Motor Gujarat.

The Company has already invested Rs 100 crores of Rs 120 crores earmarked for this facility, which is expected to commence operations from November 2017. The capex has been funded through internal accruals. This facility is expected to be running at full capacity in FY 2018-19. This facility shall cater to the requirements of Maruti Suzuki & Tata Motors in the passenger car segment along with Honda Motorcycle & Hero MotoCorp in the two wheeler space in a phased manner.

This plant will also supply the new age LED headlamps and rear lamps for the new generation Maruti Suzuki Swift platform that commences production later this year at the carmakers, Gujarat facility in Mehsana district.

Commenting on the occasion, Mr. Deepak Jain, Managing Director, Lumax Industries Limited said, “Lumax is the first lighting supplier to follow through Maruti Suzuki in Gujarat to set up the facility.
