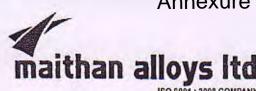

Declaration of Results of Postal Ballot

The Board of Directors of the Company had passed a resolution at its meeting held on 9th November, 2017 seeking approval of the Members by way of postal ballot pursuant to the provisions of Section 110 of the Companies Act, 2013, read with the Companies (Management and Administration) Rules, 2014 to re-classify the status of Mrs. Smriti Saraf (nee Agarwalla) from 'Promoter Group' category to 'Public' category of the Company, as stated in the Postal Ballot Notice dated 9th November, 2017 (the Notice) read with the Explanatory Statement attached thereto.

Further, the Special Resolution as set out in the Notice is considered to be approved if votes cast in favour of the resolution is not less than three times the number of the votes, if any, cast against the resolution, by the Members.

The Company had offered e-voting facility, through Central Depository Services (India) Limited (CDSL), as an alternate, to enable the Members to cast their votes electronically instead of dispatching physical Postal Ballot Form.

The last date for casting of vote through e-voting and receipt of Postal Ballot Forms, duly completed and signed by the Members was 27th December, 2017.

Considering the nature of Resolution proposed, the promoter group has opted to abstain themselves from taking part in the postal ballot voting process.

Mr. Jitendra Patnaik, company secretary in whole time practice at Kolkata, who was appointed as Scrutinizer, to receive and scrutinize the Ballot Papers received from the Members including votes cast through electronic means, submitted the results of postal ballot vide his report dated 28th December, 2017.

I, Jitendra Patnaik, Practicing Company Secretary have been appointed as Scrutinizer by the Board of Directors of M/s. Maithan Alloys Limited (the Company) at their meeting held on 9th November, 2017, for the purpose of scrutinizing the votes cast through electronic means as well for conducting the voting by postal ballot in compliance with the provisions of Section 108, 110 and other applicable provisions of the Companies Act, 2013 ('the Act') read with the Companies (Management and Administration) Rules, 2014.

Accordingly, I hereby submit my report as under:

- 1. Pursuant to Section 108 and 110 of the Act and applicable rules of the Companies (Management and Administration) Rules, 2014, the Postal Ballot Notice dated 9th November, 2017 (the Notice)together with proposed resolutions, explanatory statement under Section 102 of the Act, Postal Ballot Form, postage pre-paid business reply envelop and e-voting details were dispatched to 2,512 members of the Company through registered post and to 10,854 members via electronic mode at their e-mail addresses registered with their respective Depository Participants or the Company. The Members of the Company were also given an option to vote electronically through e-voting platform, provided by the Central Depository Services Limited (CDSL). The Company has completed the dispatch of the Notice both vide e-mail and registered post by 27th November, 2017.
- An advertisement with respect to dispatch of the Notice and conducting of voting through electronic means was published in "The Financial Express" (English newspaper) and 'ArthikLipi' (Vernacular newspaper) on 28th November, 2017.
- The e-voting period commenced on 10:00 A.M. on 28th November, 2017 and ended on 27th December, 2017 at 5:00 P.M. The CDSL portal was blocked at the end of the voting period.
