The company filed an application dated June 30, 2015, in terms of the SEBI (Settlement of Administrative and Civil Proceedings) Regulations, 2014 ('Settlement Regulations'), proposing to settle, without admitting or denying the findings of fact and conclusions of law, through a settlement order, the proposed adjudication proceedings intimated vide Notice of Approved Enforcement Action dated March 24, 2015 for the alleged violation of Rule 19(2)(b) and 19A of the Securities Contracts (Regulation) Rules, 1957.

High Powered Advisory Committee (HPAC) in its meeting dated September 04, 2017 considered the settlement terms proposed by the applicant and recommended the case for settlement upon payment of (6,00,000/- (Rupees Six Lakh only) by the applicant towards settlement terms for the aforementioned defaults.

The company has paid Rs. 6,00,000 (Rupees Six lakhs only) vide demand draft towards settlement terms for the aforementioned defaults.

## SETTLEMENT ORDER

On Application No. 2939 OF 2015

Submitted by M/s Parshwanath Corporation Limited (PAN No. AAACP9020A)

1. M/s Parshwanath Corporation Limited (hereinafter referred to as 'applicant') having address at 50, Third Floor, Harsiddha Chambers, Income Tax Cross Road, Ashram Road, Ahmedabad-380 014, filed an application dated June 30, 2015, in terms of the SEBI (Settlement of Administrative and Civil Proceedings) Regulations, 2014 ('Settlement Regulations'), proposing to settle, without admitting or denying the findings of fact and conclusions of law, through a settlement order, the proposed adjudication proceedings intimated vide Notice of Approved Enforcement Action dated March 24, 2015 for the alleged violation of Rule 19(2)(b) and 19A of the Securities Contracts (Regulation) Rules, 1957.
2. The authorised representative of the applicant had a meeting with the Internal Committee of SEBI on August 11, 2017, wherein the settlement terms were deliberated. Thereafter, the applicant, vide letter dated August 16, 2017, proposed the revised settlement terms to settle the defaults mentioned above.
3. The High Powered Advisory Committee ('HPAC') in its meeting dated September 04, 2017 considered the settlement terms proposed by the applicant and recommended the case for settlement upon payment of ₹6,00,000/- (Rupees Six Lakh only) by the applicant towards settlement terms for the aforementioned defaults. The Panel of Whole Time Members of SEBI accepted the said recommendation of the HPAC and the same was communicated to the applicant vide e-mail dated October 12, 2017.
4. The applicant vide Demand Draft no. 138826 dated October 13, 2017, drawn on HDFC Bank has remitted ₹6,00,000/- (Rupees Six Lakh only) towards the settlement charges.
5. Accordingly, the proposed adjudication proceedings for the alleged defaults as discussed in paragraph 1 above, are settled *qua* the applicant as per the above terms, by way of this order and SEBI shall not initiate any enforcement action against the applicant for the said alleged defaults.

6. In view of the above, in terms of regulations 15 and 19 of the Settlement Regulations, it is hereby ordered that:
- i. this order disposes of the said proposed adjudication proceedings in respect of the applicant as mentioned above and;
  - ii. passing of this order is without prejudice to the right of SEBI to take enforcement actions including commencing proceedings against the applicant, if SEBI finds that:
    - a. any representation made by the applicant in the present settlement proceedings is subsequently discovered to be untrue;
    - b. the applicant has breached any of the clauses/ conditions of undertakings/ waivers filed during the present settlement proceedings.
7. This settlement order is passed on this 6<sup>th</sup> day December, 2017 and shall come into force with immediate effect.
8. In terms of regulation 17 of the Settlement Regulations, a copy of this order shall be sent to the applicant and shall also be published on the website of SEBI.
