This is to inform you that the National Company Law Tribunal, Telangana vide its order no:CA265/97/HDB/2017 dated  $22^{nd}$  December 2017 has passed an order directing the Company to postpone its forthcoming  $34^{th}$  Annual General Meeting of the company to be held on  $29^{th}$  December 2017.

The legal heirs of the deceased shareholder late Mr M Raghuveer, a major shareholder of the Company holding 72.08% of the equity shares of the Company have moved a petition before the NCLT, Hyderabad for allowing them to attend and vote at the AGM as the shareholding is not yet transferred in their name.

However the Tribunal stated in absence of succession certificate, the shares of the deceased cannot be transmitted in favour of the legal heirs. Hence ordered the Company to defer holding of the 34<sup>th</sup> AGM proposed to be held on 29<sup>th</sup> December 2017 till the next date of hearing. The case has been posted on 22<sup>nd</sup> January 2018.

#### ORDER

1. The Company Application bearing No. C.A.No.265/97/HDB/2017 is filed by Smt.Myadam Sugandha Bai & Another under Section 97 read with 241, 242 and 244 of the Companies Act, 1956 by inter alia seeking to pass an order to directing the Company to permit the applicants to participate in Annual General Meeting (AGM) scheduled to be held on 29.12.2017 and to allow them to exercise their right to vote. They have also prayed for Interim Relief to direct the Company to permit them to participate in the said AGM.

### 2. Brief facts of the case:

- i. Bambino Agro Industries Limited was promoted by Myadam Janardhan Rao and Myadam Kishan Rao as Private Limited Company under the name "Jaya Food Industries Private Limited" to carry out the business of producers, manufacturers in all kinds of food products. The Company was issued certificate of incorporation on 31.12.1983 by Registrar of Companies, Andhra Pradesh. The Registrar of Companies, Andhra Pradesh by certificate dated 30.10.1992 converted "Jaya Food Industries Pvt. Ltd" to "Jaya Foods Industries Ltd" under section 31(1)/44 of the Companies Act, 1956.
- 3. As on 24.02.2016, late M.Raghuveer S/o. Myadam Kishan Rao, one of the promoters of Respondent No.1 Company was holding 14,86,542 equity shares of the total paid up capital of Respondent No.1 Company. However, certain shareholders namely M.Kishan Rao S/o. M.Anjiyah, M.Sugandha Bai W/o. M.Kishan Rao, M.Subramanyam S/o.M.Kishan Rao and other family members transferred their shareholding of Respondent No.1 Company in



favour of Late M.Raghuveer. With the above transfer Shri M.Raghuveer became lawful owner of 72.08% equity shares of Respondent No.1 Company constituting 57,72,858 fully paid up equity shares and the same was notified to the Bombay Stock Exchange, where the shares of the Respondent No.1 Company is listed.

4. Unfortunately Shri M.Raghuveer died on 25.06.2017 left behind the following legal heirs namely:

5. Late M.Raghuveer at the time of demise was acting as Chairman & Managing Director and later the board of directors in their meeting held on 06.07.2017 appointed Shri M.Kishan Rao as Chairman & Managing Director of the Company.



- 6. At the time of demise the deceased was holding 57,72,858 equity shares of Rs.10/- each of Bambino Agro Industries Ltd. and the said equity shares was held by him in his two Demat Accounts as detailed hereunder:
  - a. Demat A/c.No.IN301022, Client ID 20716077,
     M/s.Stockholding Corporation of India Limited,
     Secunderabad Branch. No. of Shares = 49,72,858
  - b. Demat A/c.No.IN302437, Client ID 20005594, Indian Overseas Bank, Chennai. No. of Shares = 8,00,000
- 7. The equity shares of deceased could not be transmitted in favour of the applicants in absence of succession certificate. Also AGM could not be conducted for the year ending on 31.03.2017 within the period prescribed u/s 96 of the Companies Act, 2013. The RoC by letter dated 29.08.2017 granted extension of three months to hold the said AGM before expiry on 31.12.2017.

The applicants by letter dated 28.11.2017 requested the Board of Directors to defer holding of AGM pending orders of the Succession Certificate but same was declined by communication dated 28.11.2017.

- Accordingly, the Company is decided to convene 34<sup>th</sup> Annual General Meeting on 29.12.2017 at 9.30am at KLN Prasad Auditorium, Federation of Telangana and Andhra Pradesh Chambers of Commerce and Industry (FTAPCCI) Federation House, 11-6-841, Red Hills, FAPCCI Marg, Hyderabad – 500014.
- 10. The Applicants also submit that they filed a petition for issue of succession certificate u/s 372 of Indian Succession Act, 1925 in the Court of Hon'ble III Senior Civil Judge, City Civil Court, at Secunderabad and the same is pending.
- 11. The Applicants also submits that they approached the Civil Court on 18.12.2017 by seeking restraining the Company from holding the proposed AGM and the said application is pending on the file of Civil Court. Therefore, the present application has been filed seeking relief as stated above.



- 12. Heard Shri Yogesh Kumar Jagia, Learned Counsel for the Petitioner and Shri T.Natraj, Learned Counsel for the Respondent. The Counsel for Respondent No.1 Company submit that he takes notice from the Petitioner and waives further notices and he is filing Vakalat today and further submit that he has No Objection to grant prayer as sought for.
- 13. Since the rules did not permit to transmit the shares of the deceased person without succession certificate, it is necessary to approach the Civil Court to get succession certificate declaring the Petitioners as legal heirs of the deceased person. He approached the Civil Court to withdraw the application on 20.12.2017 and he would withdraw the IA filed in Succession OP No.38 of 2017 in a day or two.
- 14. In the light of the facts of the case, we direct the Respondent Company to defer holding of AGM proposed to be conducted on 29.12.2017 till the next date of hearing and also directed the Company to intimate to all the concerned including Stock Exchanges, Shareholders, RoC and other Statutory Authorities immediately.

15. Post the case on 22.01.2018.
