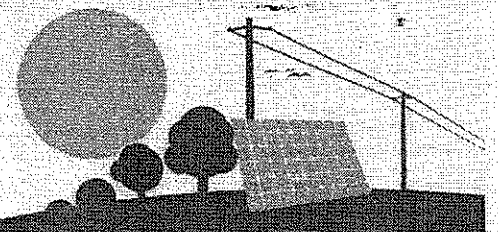

dress to gently prod the organisers for the faux pas, the president asked them to stop distributing the packets till his speech was over. While addressing the centenary conference of the association, Kovind noticed that the food packets were being distributed among the participants. "Two minutes into his speech, Kovind paused and

looked at the audience as there was a sudden noise. The volunteers had started distributing the food packets among the delegates and mediapersons and a group of students had got up from their seats in their hurry to grab them. "This is happening in the economic world... I see the same picture at this conference also. I think some food packets are be-

ing distributed. Of course it is a must, but it has disturbed the system itself. "Therefore, I request the organisers, will you please keep the distribution of food packets in abeyance for a little while," Kovind said, even as the stunned police personnel and officials intervened to stop the distribution. The president then continued with his speech.

Parliament passes bill amending Forest Act

New Delhi

Parliament on Wednesday passed a bill to exclude bamboo from the definition of tree under the Indian Forest Act, claiming it would improve the earnings of tribals and the people living around forests. The Indian Forest (Amendment) Bill, which was adopted by the Lok Sabha on December 20, was passed by a voice vote in the Rajya Sabha, amid a walk-out by member of the Congress, Biju Janta Dal and the Samajwadi Party. The opposition parties protested its passage saying the bill was being passed in a hurry without proper consultations with stakeholders and the

states. Besides, they alleged it would favour the industrialists. Replying to a short debate, Environment, Forest and Climate Change Minister Harsh Vardhan said the bill to amend the 1927 Indian Forest Act would benefit the tribals, forest dwellers and farmers as their incomes would increase. "The bill permits felling and transit of bamboo grown in non-forest areas. However, bamboo grown on forest lands would continue to be classified as tree and would be guided by the existing legal restrictions. "I am really shocked to see that you (opposition) can't see the benefit of tribals and poor farmers who are going to benefit after the bill is passed," he told the House amid protest from the opposition members.

Armed forces facing shortage of nearly 60,000 personnel: Govt

New Delhi

The armed forces are facing a shortage of nearly 60,000 personnel with the Army topping the list with over 27,000 vacant posts, the government said on Wednesday. According to the details provided by Defence Minister Nirmala Sitharaman in Lok Sabha, the shortage of officers in the Army, Navy and the Indian Air Force is 8,959 while the number for below officer rank is 50,363. Replying to a question, she said the total strength of the Army as on July 1 is 12.87 lakh personnel against the authorised strength of 12.64 lakh and the total shortage is 27,884. The current strength of the Navy is 67,226 personnel and the number of vacant positions is 16,255. She said the Indian Air Force is facing a shortage of 15,403 personnel against the authorised strength of 1.55 lakh. The vacancies existing personnel in dental and medical streams come to 59,622. The recruitment in the armed forces is a continuous process. The government has taken a number of measures to reduce the shortages, she said.

'Govt yet to receive proposal to fill up judges' vacancies in SC'

NEW DELHI: There are six vacancies of judges in the Supreme Court, while nine high courts are working without regular chief justices, but the government has not received any proposal from the apex court collegium to fill up the slots, the Rajya Sabha has been informed. Union minister of state for law P Chaudhary, in a written reply has informed the Upper House of Parliament that the "government has not received any proposal for filling up of the six vacancies of judges in the Supreme Court and for appointment of chief justices in the nine high courts, which are functioning with acting chief justices".

Jaya video: AIADMK leader moves HC for anticipatory bail

CHENNAI: Disqualified AIADMK MLA P Velupillai has moved the Madras High Court, seeking anticipatory bail in a case filed against him for releasing a video, purportedly showing late party chief of Jayalitha lying on a hospital bed. Velupillai, a staunch loyalist of sidelined AIADMK leader TTV Dhinakaran, in his petition, submitted that he apprehended arrest in the case filed by the police and sought the relief. He moved the high court as the district principal sessions court here had, last week, rejected his plea for anticipatory bail.
