Sub: Scrutinizer's Report on Postal Ballot process including voting by electronic means conducted pursuant to Section 108 and 110 of the Companies Act, 2013 ('The Act')read with Rules framed there under, Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No CIR/CFD/CMD/16/2015 dated 30th November 2015 and Secretarial Standard 2 (SS-2)

I, K KSachdeva, (Practicing Company Secretary), have been appointed as the Scrutinizer by the Board of Directors of Rico Auto Industries Limited having its registered office at 69 KM Stone, Delhi-Jaipur Highway, Dharuhera, Distt. The Management of the Company was responsible to ensure the compliances with requirements of the Companies Act, 2013 and Rules framed there under relating to Postal Ballot process including e-voting on the items/resolutions contained in Notice of Postal Ballot of the Company dated 9th November, 2016 including the dispatch of Notice to all the members of the Company as prescribed in the Act and Rules.
