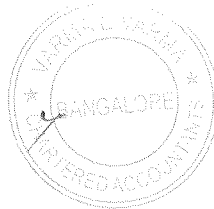

**LIMITED REVIEW REPORT**

We have reviewed the accompanying statement of unaudited consolidated financial results of **Suprajit Engineering Limited** ('the Company') comprising of Suprajit Engineering Limited and its subsidiaries ('the Group') for the quarter and nine months ended December 31, 2016 ('the Statement') attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. This statement is the responsibility of the Group's Management and has been approved by the Board of Directors. Our responsibility is to issue a report on this statement based on our review.
2. We conducted our review in accordance with the Standard on Review Engagement (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
3. We did not review the unaudited standalone financial results of three direct subsidiaries and the unaudited consolidated financial results of one direct subsidiary of the Company considered in the preparation of the accompanying Statement which constitute revenues and net profit of INR 4,38,09.45 lakhs and INR 34,47.83 lakhs respectively for the nine months period referred to above. The unaudited financial results and other financial information in respect of these four subsidiaries are based on management certification of which unaudited consolidated financial results of one direct subsidiary having revenue and net profit of Rs 2,57,26.02 lakhs and 21,26.78 lakh respectively is subjected to limited review by its statutory auditors and is filed with the Indian Stock Exchanges. Accordingly, our opinion on the Statement, to the extent they have been derived from such financial results is based solely on the said management certification and limited review. We are unable to comment on the impact if any, on the financial results for the nine months ended December 31, 2016 had the financial results of these three subsidiaries also been reviewed by their auditors.



4. We have not reviewed the accompanying consolidated financial results for the nine months ended December 31, 2015, which have been presented solely based on the information compiled by the management.
5. Based on our review conducted as above and on consideration of other financial information of the components, except for the possible effect of our observation in para 3 above, nothing has come to our attention that causes us to believe that the accompanying Statement prepared in accordance with applicable accounting standards and other recognized accounting practices and policies has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations including the manner in which it is to be disclosed, or that it contains any material misstatement.
