**NOTICE OF EXTRA-ORDINARY GENERAL MEETING**

Pursuant to the provisions of Section 108 of Companies Act, 2013 read with Rules made thereof and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 the Company is providing e-voting facility to its Members holding shares on Friday February 24, 2017, being cut off date, to exercise their vote on business to be transacted at the EGM of the Company. 2. The Remote e-voting period:  
Commences on: February 28, 2017 (Tuesday) at 9.00a.m.  
Ends on: March 02, 2017 (Thursday) at 5.00p.m.
3. The voting through electronic means shall not be allowed beyond March 02, 2017 (Thursday) at 5.00p.m.
4. Any person who becomes the member of the Company after the dispatch of the Notice of EGM and holding the shares as on the cut-off date i.e. February 24, 2017, can send request to voraconstructions@gmail.com.
5. The Notice of EGM is also available on the Company's website www.voraconstructions.com and on NSDL website www.evoting.nsdl.com.
6. In case you have any queries or issues regarding e-voting, you may refer the Frequently Asked Questions (FAQs) for Members and remote e-voting user manual for Members available at the download section of www.evoting.nsdl.com or call on toll free no. 1800-222-0990.
7. A member may participate in the EGM even after exercising his right to vote through remote e-voting but shall not be allowed to vote again in the meeting. Scrutinizers decision on the validity of vote shall be final.
