- 1. The Board of Directors of M/s.  - (iv) Particulars of all the postal ballot forms received from the Members have been entered in a register separately maintained for the purpose.
 - (v)The postal ballot forms were kept under my safe custody in sealed and tamper proof ballot box before commencing the scrutiny of such postal ballot forms.
 - (vi) The ballot box was opened on 08.02.2017 after the closing hours in my presence and the votes cast through e-voting were unblocked after the completion of E-voting process at 12.42 P.M. on Thursday the 9th day of February, 2017, in the presence of 2 witnesses, Ms. Manasi Rao & Mr. Gokul Raja, who are not in the employment of Company.

(vii)The votes cast through postal ballot forms and e-voting platform were scrutinized and the shareholding was matched/ confirmed with the Register of Members of the Company / list of beneficiaries as on 30.12.2016.
