

This disclosure is being made on account of a transfer of 16,134,016 equity shares carrying voting rights of the Target Company comprising 9.07% of the total voting share capital of the Target Company by Ashok Anand Chandavarkar to Leo Advisors Private Limited.


In addition to the transfer of equity shares carrying voting rights from Ashok Anand Chandavarkar to Leo Advisors Private Limited, Mangala Ashok Chandavarkar is also transferring 6.05% of the voting share capital of the Target Company held by her to Virgo Advisors Private Limited for which a separate disclosure under Regulation 29(2) of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 is being filed.

Note 2:

The transfers of equity shares set out herein are between members of the promoter group. As such, the aggregate holding of the promoter group of the Target Company remains unchanged pursuant to the consummation of such transfers.

(*)Total share capital/ voting capital to be taken as per the latest filing done by the company to the Stock Exchange under Clause 35 of the listing Agreement.

(**) Diluted share/voting capital means the total number of shares in the TC assuming full conversion of the outstanding convertible securities/warrants into equity shares of the TC.
