

BEML BAGS Rs.1421 CRORE ORDER FROM BMRCL

BEML LIMITED, a Public Sector Mini Ratna Category-I Company under the Ministry of Defence and the premier manufacturer of Metro Cars, has bagged a prestigious Order of Rs.1421 Crore from Bangalore Metro Rail Corporation for supply of 150 sets of Intermediate Metro Cars to augment the existing 3 Car Trains supplied by BEML to 6 Car trains.

An agreement to this effect was signed. Shri Pradeep Singh Kharola, Managing Director, BMRCL and Shri Deepak Kumar Hota, Chairman & Managing Director, BEML have exchanged the Contract Agreements. Shri Aniruddh Kumar, Director, Rail & Metro Business of BEML was also present on the occasion. The supply of Intermediate Metro Cars to BMRCL shall commence from June 2018 and to be completed by December 2019.

BEML has forayed into the manufacture and supply of hi-tech Metro Cars during 2002. Since then, BEML had made significant strides and emerged as the preferred destination for Metro Coaches in the Country.
