Note 1:

There is no direct transfer of equity shares carrying voting rights of the Target Company. This filing is being made on account of a proposed transfer of equity shares of Kajaria Securities Private Limited (“KSPL”). KSPL in turn holds 64365138 equity shares constituting 40.50% of the voting share capital of the Target Company. In particular, Ashok Kajaria, A.K. Kajaria (HUF), Rishi Kajaria, Chetan Kajaria and Versha Devi Kajaria (collectively, “**Transferors**”) propose to transfer equity shares of KSPL as part of settlement contributions of Rishi Kajaria Family Private Trust, Versha Kajaria Family Private Trust and Chetan Kajaria Family Private Trust in the manner set out below (“**Proposed Transaction**”). The transfer of shares of KSPL will be undertaken as a gift.






