## Sub: Voting Results of the Postal Ballot Process (including e-voting) conducted by the Company pursuant to Regulation 44 of the SEBI (LODR) Regulations, 2015.

Pursuant to Section 110 of the Companies Act, 2013 read with Companies (Management & Administration) Rules, 2014, the Company had sought approval of the Members for amendment to terms approved earlier by the shareholders at their EGM held on December 10, 2015 pertaining to RPTs and approval of Related Party Transactions (new) under Section 188 of the Companies Act, 2013 & Regulation 23 (4) of the SEBI (LODR) Regulations, 2015 by way of Postal Ballot including voting through electronic means (hereinafter referred as 'e-voting') in accordance with Section 108 of the Companies Act, 2013 read with the Companies (Management & Administration) Rules, 2014 and Regulation 44 of the SEBI (LODR) Regulations, 2015. The voting period commenced from February 20, 2017 at 10.00 a.m. (IST) and concluded on March 21, 2017 at 5.00 p.m. During this period, the members holding shares, either in physical or in dematerialized form, as on the close of business hours on February 17, 2017 were eligible to vote on the resolution as stated in the Postal Ballot Notice dated February 09, 2017.

Mr. Nitin R. Joshi, Practicing Company Secretary, was appointed as the Scrutinizer for the Postal Ballot and e-voting process in a fair and transparent manner. The Scrutinizer has submitted a consolidated report on the entire voting to the Managing Director of the Company.

The consolidated voting results in terms of Regulation 44 of the SEBI (LODR) Regulations, 2015 and the Report of the Scrutinizer dated March 22, 2017 are enclosed herewith.
