- 1. I, Rajesh Karunakaran, Practicing Company Secretary (F.C.S. No. 7441), appointed as Scrutinizer by:
- (I) the Board of Directors of Foseco India Limited (the Company) for the purpose of scrutinizing e-voting process in a fair and transparent manner under the provisions of Section 108 of the Companies Act , 2013 (the 2013 Act) read with Rule 20 of the Companies (Management and Administration) Rules 2015 as amended and
- (II) the Chairman of the 60^{th} Annual General Meeting (AGM) on Poll under the Provisions of Section 109 of the 2013 Act read with Rule 21 of Rules, on the resolutions contained in the Notice to the Annual General Meeting (AGM) of the Members of the Company held on Thursday, 27^{th} April 2017 at the Registered Office of the Company at Gat No. 922&923, Sanaswadi, Taluka Shirur Pune 412 208, Maharashtra.
- 2. The Management of the Company is responsible to ensure compliance with the requirements of the Companies Act 2013 and Rules relating to remote e-voting and poll on the resolutions contained in the Notice to the Annual General Meeting of the Members of the Company. My responsibility as a scrutinizer for the remote e-voting process and for the poll is restricted to make a Scrutinizers Report of the votes cast in favour or against the resolutions

stated above, based on reports generated from the remote e-voting system provided by Central Depository Services Limited , the authorised agency engaged by the Company to provide remote e-voting facilities for remote e-voting and based on the Physical votes cast by ballot by Members/Proxies at the AGM .

- 5. The Cut –Off date for the purpose of determining the entitlement for voting , by remote e-voting or voting through polling paper , on the proposed resolutions was Thursday , 20^{th} April 2017 (Item No. 1 to 5) as set out in the Notice of the 60^{th} Annual General Meeting of Foseco India Limited .
- 6. The votes cast through remote e-voting facility were unblocked on 27^{th} April 2017 after 1.30 p.m. (after the conclusion of the 60^{th} Annual General Meeting) in the presence of Mr. Manoj Kalani and Mr. Subhash Adawal who are not in the employment of the Company .
