Bennett, Coleman & Company Limited (BCCL) has acquired 23,00,000 and 18,00,000 equity shares of FRETAIL from its PACs' i.e. Vardhaman Publishers Ltd. & Dharmayug Investments Ltd. respectively. Hence, shareholding of BCCL in FRETAIL increased from 4.32% to 5.19% However, aggregate shareholding of BCCL in FRETAIL along with PACs remained same post acquisition i.e. 11.03%.
