MGN Agro Properties Private Limited (“Transferor”), promoters of the Target Company, held 72.67% voting rights in the Target Company. Pursuant to restructuring of promoter shareholding, 72.67% voting rights held by the Transferor stand vested in the Acquirer. In terms of Regulation 10(1)(a)(iii) of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, such acquisition of voting rights by the Acquirer is exempt from an obligation to make an open offer under Regulation 3 and Regulation 4 of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011.
