






**# Note:**

This disclosure is in respect of the following:

As a part of family restructuring exercise, Mrs. Nethra J.S.Kumar being wife of Mr. D. Senthilkumar has settled 49.98% shareholding in Eshaan Enterprises Limited (EEL) in favour of Mr. D. Senthilkumar in his capacity as a trustee of Sree Venkata Vishnu Trust. EEL holds 2.10% of the share capital of the TC.

Accordingly, Mrs. Nethra J.S.Kumar indirectly disposed shares in EEL to Mr. D. Senthilkumar (in his capacity as a trustee of Sree Venkata Vishnu Trust) which in turn holds 2.10% shareholding in the TC. While strictly speaking Mrs. Nethra J.S.Kumar cannot be said to have disposed control over EEL, this disclosure is being made by way of abundant caution.
