Sub: Reporting under SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011

DSP BlackRock Trustee Company Pvt. Ltd (DSPBRTC) is the Trustee for the schemes launched by DSP BlackRock Mutual Fund (Fund). DSPBRTC on behalf of the schemes of the Fund has sold equity shares of Indian Terrain Fashions Limited (Company).

DSPBRTC had in past vide its letter dated January 30, 2015 reported the increase of holding across various schemes of the Fund beyond 5% of the paid up capital of the Company i.e. at 8.02% in accordance with Regulation 29(1) of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 ('Regulations').

Further, as per Regulation 29(2) of the Regulations, if there has been change in such holdings from the last disclosure made under sub-regulation (1) and such change increases/decreases two per cent of total shareholding or voting rights in the target company, the same needs to be disclosed.


One of the Scheme viz. DSP BlackRock 3 years Close ended Equity Fund has sold 700,000 shares of the Company due to which the shareholding in the Company via various schemes has decreased to 5.94% of the paid up capital of the Company i.e. more than 2% since it was last reported.

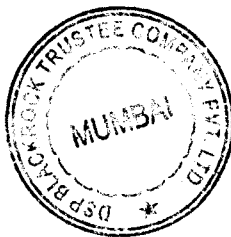
