NOTICE

NOTICE is hereby given to the shareholders of the Company in terms of Rule 6 of the Investor Education and protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016 and proviso thereto (hereinafter called the Rules). The unpaid / unclaimed dividends have been transferred from time to time as per the applicable provisions of the Companies Act, 1956 and/or Companies Act, 2013 (hereinafter referred to as the Act) to the Central Government / Investor Education and Protection Fund (IEPF).

The Rules have been enforced with effect from 7th September, 2016 (amended on 28th February, 2017). Pursuant to Section 124(6) of the Act read with Rule 6 of the Rules, all shares in respect of which dividend has not been paid or claimed for seven consecutive years or more, shall be transferred by the Company in the name of Investor Education and Protection Fund.
