KERALA-BASED KALYAN Jewellers announced on Monday that an affiliate of PE firm Warburg Pincus is investing an additional ₹500 crore in the company, taking the total investment to ₹1,700 crore. In 2014, the firm had invested ₹1,200 crore in Kalyan Jewellers marking it the highest PE investment in the jewellery sector in the country.

The retail jeweler is planning to double its presence to 200 plus showrooms. Currently, the retailer has 105 showrooms across India and West Asia. In 2014, the company management had hinted that the stake sale amounted to 10% with the valuation at that time pegged at ₹12,000 crore. The company had also mentioned that it would go

for an IPO shortly. "In the next three years, Kalyan Jewellers will build its presence in the central region of the country including Uttar Pradesh and Madhya Pradesh and add new showrooms in Mumbai, Delhi and the Southern region. Kalyan is also looking to expand international operations by entering into new markets such as Saudi Arabia, Bahrain, Oman, Singapore and Malaysia. The Company will also bolster its presence in the UAE where it already has 13 showrooms," TS Kalyanaraman, chairman and managing director said.

Commenting on the new development Kalyanaraman added, "The investment by Warburg Pincus is a vindication of the strong growth trajectory of

the company. The company plans to nearly double its presence to 200 plus showrooms using a combination of equity, debt and internal accruals. Kalyan is also working on a blueprint for a foray into the e-commerce segment which will complement our physical retail network. We believe that the curb in cash transactions will see a shift from the unorganized sector to organized players like Kalyan. The rationalization of taxes under the GST regime will increase opera-

tional efficiencies significantly." Vishal Mahadevia, managing director, Warburg Pincus India said, "We see a tremendous opportunity for Kalyan Jewellers to build a strong branded designled jewellery business. Warburg Pincus' additional investment will be used to accelerate the company's growth efforts in network expansion and pursuing acquisition opportunities."


