Sub.: Public Notice issued by Karnataka State Pollution Control Board (KSPCB).**


We refer to the Public Notification dated 05.05.2017 (copy enclosed) issued by KSPCB directing closure of all industrial units within the catchment area of Bellandur Lake, Bengaluru. Pursuant to the above notice, the Company hereby informs the temporary closure of its Facilities at Adugodi, Bengaluru, being one of the industrial units/facilities listed in the website of KSPCB with effect from today.

It has also been notified that the orders of closure against individual industries will be revoked pursuant to inspection by KSPCB and their report thereon as to the compliance by the industries with the prescribed standards and norms.

The Company has always upheld highest standards with respect to environment protection and is confident that it has been operating within the prescribed environmental norms at all its facilities. The Company is reviewing the directions of KSPCB and will consider all options for suitable relief in order to re-commence the operations at the earliest at Adugodi, Bengaluru. The Company will endeavour to take necessary measures to ensure deliveries to the Customers are not affected.

The approximate loss of turnover per day is INR 393 lakhs, in case supplies to customers are affected. Any further development will be informed at the earliest.

DIRECTION

(UNDER SECTION 33(A) OF WATER (PREVENTION AND CONTROL OF POLLUTION) ACT, 1974 AND RULE 34(6) OF WATER (PREVENTION AND CONTROL OF POLLUTION) RULES, 1976.)

The Principal Bench of Hon'ble Green Tribunal vide order dated: 19-04-2017 in Original Application No: 217/2017 and 125/2017 (MA No: 440/2017) has issued the following directions with regard to pollution of Bellandur Lake.


" All the industries which are located in the catchment area of the Bellandur Lake and are discharging their effluent (treated or untreated) into the water body are hereby directed to be closed forthwith. No industry shall be permitted to operate unless they have been subjected to an inspection by the joint inspection team and their analysis of the effluent are found to be within the permissible limit. The Pollution Control Board shall ensure that these industries are shut down immediately and if any industry or person is found to be violating these instructions or directions, the same shall be sealed by the Pollution Control Board and the Government would provide all assistance and help, including the police aid, to the Pollution Control Board".

Therefore, the Karnataka State Pollution Control Board (the "Board"), in exercise of the powers vested under section 33(A) of the Water (Prevention and Control of Pollution) Act, 1974 and rule 34(6) of the Karnataka Water (Prevention and Control of Pollution) Rules, 1976 hereby directs that all the industries in the catchment area of Bellandur Lake, Bengaluru that are discharging their effluent (treated or untreated) into the water body shall shut down with immediate effect (List of industries /industrial units /factories on the records of the Board are available in the website of the Board at <http://kspcb.gov.in>).

This Public Notice may be treated as individual notice(s) to each of the concerned industry/industries. Specific individual directions shall also follow.

The Board will initiate action with regard to reopening of such industries after inspection by the joint inspection team (comprising of the Board and Central Pollution Control Board Officers) constituted by the Board, to verify optimal functioning of the effluent treatment system and upon finding that the treated effluent discharged are found to be in accordance with stipulated standards.
