PRESS RELEASE

Pudumjee Paper Products Limited has reported turnover at Rs.543.89 crores for year ended 31.03.2017 (last year Rs.494.72 crores). During this year the Company has sold 60483 MT of paper, an 23% increase over 49292 MT of paper sold during last year. The EBIDTA during this period grew by 34 percent to Rs.46.97 crores (last year Rs.34.93 crores) and the Profit After Tax rose sharply by 96 percent to Rs.19.87 crores (last year Rs.10.12 crores). The sharp increase in the working has been on account of change in product mix and market strategy, and comparatively lower input costs in the paper division of the Company. The Company has declared dividend @ 15% (last year 10%).

The Company's is on the verge of completion of full width supercalender project and 132 KVA Substation which are expected to supplement the efforts of the Company for better profitability.
