Kakkad will be produced in a special court in Mumbai on Saturday.

# Govt looking at winding up unsafe coal mines. says Goval

PRESS TRUST OF INDIA Vienna, May 12

THE GOVERNMENT IS planning to soon shut some of the mines of state-owned Coal-India that are relatively unsafe and produce small quantity of coal. The plan follows announcement of a safety audit of all the 418 mines in the country in the aftermath of one of the worst disasters in Jharkhand that claimed at least 18 lives.

"We have done the safety audit of all the coal mines, particularly the underground mines. So, we will soon be taking a view on some of the unsafe mines where we think it may be better not to produce... which are of a very small quantity," coal and power minister Pivaish Goval said
