The Statutory auditors have expressed an unmodified opinion. The audit report has been filed with the Stock Exchange and is available on the Company's website.
- 2. The figures for three months ended 31 March 2017 and 31 March 2016 are arrived at as a difference between audited figures in respect of full financial year and the published figures upto nine / twelve months of the relevant financial year / period.
- 3. The Board of directors at its meeting held on 19 February 2015 decided to change the financial year of the Company from January-December to April-March. Accordingly, the year to date figures for the current period are for the 12 months ended 31-March-2017 and year to date figures for the corresponding period are for the fifteen months ended 31-March-2016. Hence the figures are not comparable. The previous year accounting period was for 15 months from 1-January-2015 to 31-March-2016.
- 4. The Board of Directors at its meeting held on 8 May 2017 have recommended a dividend of Rs. 2 Per equity share for the year end 31 March 2017 to the shareholders subject to the approval of the shareholders in the ensuing Annual General Meeting.
- 5. The Company operates in a single business segment namely "Electrolytic products". The disclosure requirements of the Accounting Standard (AS) 17 'Segment Reporting' notified under Section 133 of the Companies Act, 2013, read with Rule 7 of the Companies (Accounts) Rules, 2014 are not applicable.

6. The figures for the previous periods have been regrouped/reclassified wherever necessary to conform to the current period's presentation.
