CERA DECLARES 240 % DIVIDEND

In yet another year of robust performance CERA Sanitaryware Limited has achieved a 10% topline growth for the fiscal 2016-17 on a net sales income of Rs.1009.17 crores compared to Rs.917.24 crores in the previous fiscal year ended March 31 2016.

The company has declared a dividend of 240 %.

According to audited results released after a meeting of the company's board, the growth in the net profit was even better with a 21 % rise. The net profit was Rs.101.31 crores for the year under review as against net profit of Rs.83.46 crores during 2015-16.

CERA achieved net sales earnings of Rs.311.24 crores in the fourth quarter (January-March) 2017 as compared to Rs.275.84 crores in the last quarter of previous fiscal. The net profit for Q4 was Rs.32.30 crores as against Rs.29.80 crores during January-March 2016.

The earnings per share stood at Rs.77.90 compared to Rs.64.17 during 2015-16.
