5	The Figures of Standalone and Consolidated Financial Results for the quarter ended 31st March, 2017 are the balancing figures between audited figures in respect of full financial year and the published year to date unaudited figures upto 31st December, 2016, which were subjected to limited review.
6	The above consolidated Financial Results include financials of PPAP Tokai India Rubber Private Limited, Joint Venture of the Company in which the Company holds 50% stake and three associate companies.
7	The figures have been regrouped /rearranged wherever required for the purpose of comparison.
