

Note 1: Due to preferential allotment pursuant to and in terms of Chapter VII of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations 2009, as amended, of 3,88,65,582 Equity Shares on May 10, 2017 to Cinnamon Capital Limited, a Category III foreign portfolio investor registered with Securities and Exchange Board of India, the paid-up capital of the Company has increased from 35,38,56,920 Equity shares to 39,27,22,502 Equity shares and, consequently, voting rights of PACs have decreased on their existing shareholdings, without any change in the number of shares held by them.
