

- 1 The business activity of the Company falls within a single primary business segment viz 'Ceramic Tiles and Allied products' and hence there is no other reportable segment as per Accounting Standard 17 'Segment Reporting'.
- 2. The Board of Directors has recommended a dividend of 135% (Rs. 2.70 per equity share of Rs. 2/- each) for the financial year 2016-17.
- 3. The Board of Directors approved modernization and upgradation of certain production lines at (i) Kassar (Haryana) Plant which will result into increase in capacity of value added tiles by 2.50 million square meteres per annum and (ii) Kadi (Gujarat) Plant to improve the value added mix with decrease in capacity by 1.77 million square meters per annum.
- 4. Out of Rs. 12,000 lakhs raised through qualified institutions placement of equity shares in previous year, the Company has so far utilized Rs. 1,850 lakhs (including issue expenses of Rs. 307 lakhs) for the purposes the fund were so raised and balance Rs. 10,150 lakhs has been temporarily invested mainly in the debt instruments/funds.
- 5. Exceptional item of Rs. 406 lakhs primarily pertains to impairment of certain plant and machineries.
- 6. The Board of Directors also approved termination of Joint Venture Agreement with Keraben Grupo S.A. The SKPL Ceramics Private Ltd (previously Somany Keraben Private Limited), the Joint Venture Company has not been in operations for last few years.
- 7. Figures of the last quarters are the balancing figures between audited figures in respect of the full financial years and the published year to date figures upto the third quarters of the respective financial years.
- 8. Figures of the previous period(s) have been regrouped / rearranged wherever necessary to conform to the current quarter's / year's classification.
- 9. The above results were reviewed by the Audit Committee and approved by the Board of Directors in their respective meetings held on 24th May, 2017.
