पणजी, 30 मई (भाषा)।

गोवा के मुख्यमंत्री मनोहर परीकर ने कहा कि राज्य सरकार 18 जून को अपना न्यूनतम साझा कार्यक्रम (सीएमी) पेश करेगी।

राज्य विधानसभा के खंडित चुनाव परिणामों के बाद इस साल मार्च में कई अन्य छोटी पार्टियों के ने पांच पुलिसकर्मियों के गठबंधन से भाजपा नेतृत्व वाली राज्य सरकार रोषी करार दिया था। बनी। पिछले महीने परीकर ने कहा था कि सरकार प्त के साथ सामृहिक अपने सभी गठबंधन सहयोगियों- भाजपा, गोवा वार के सात सदस्यों फॉरवर्ड पार्टी, महाराष्ट्र गोमंतक पार्टी और लोगों को 21 जनवरी निर्दलीयों के परामर्श से एक न्यूनतम साझा मूहिक बलात्कार और कार्यक्रम अंगीकृत करेगी।

यहां की एक विशेष अदालत मुंबई के वर्ष 1993 के सिलिसिलीवार बम विस्फोट के मामले में गैंगस्टर अबू सलेम, मस्तफा दोसा और चार अन्य की कथित संलिप्तता से जुड़े मामले में 16 जून को फैसला सुना सकती है।

आतंकवाद एवं विध्वंसक गतिविधियां (रोकथाम) अधिनियम (टाडा) अदालत ने सलेम, दोसा और चार अन्य के खिलाफ अलग सुनवाई की थी क्योंकि चे पहले फरार थे। इससे पहले इस मामले में याकूब मैमन और मेमन परिवार के अन्य सदस्यों एवं अभिनेता संजय दत्त समेत 100 लोगों को 2006 में दोषी ठहराया गया था।सलेम और दोसा के अलावा इस मामले के अन्य आरोपी फिरोज खान, ताहिर मर्चेंट, रियाज सिद्दीकी और अब्दुल कय्यूम हैं। मुंबई में 12 मार्च, 1993 को हुए सिलसिलेवार बम विस्फीट में 257 लोगों की मौत हो गई थी और 713 अन्य घायल हुए थे।
