Sub: Consolidated Scrutinizer's Report u/s 108 & 110 of the Companies Act, 2013 for voting by equity shareholders through Postal Ballot & e-voting.

The Management Committee of the Company at its meeting held on $25^{\rm th}$ April, 2017 has appointed us as Scrutinizer for the postal ballot and remote e-voting process.

Pursuant to Section 108 and 110 of the Companies Act, 2013 (the Act) read with Companies (Management and Administration) Rules, 2014 and Regulations 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, the Company has provided postal ballot and remote e-voting facility to its members in respect of special resolutions as mentioned in the notice dated 8th May, 2017 for postal ballot and remote e-voting to the equity shareholders of the company.

The Company has appointed Central Depository Services (India) Limited (CDSL) as the Service Provider, for the facility of electronic voting to the shareholders of the company.
