High Court sets aside contract for 104 services in State

Directs govt to issue a fresh notification for inviting tenders and select an agency by constituting tender committee; process should be completed by August 31

FINDING fault with the decision making process of the Andhra Pradesh government in awarding the tender for providing '104' services, the High Court on Friday set aside the contract awarded to Piramal Swasthya Management and Research Institute (formerly HMDI).
The court directed the State...

government to issue a fresh notification for inviting tenders for the said services and select the agency by constituting an appropriate tender committee and to complete the tender process by August 31 this year.
Justice A Ramalingeswara Rao was passing this judgment on a petition by Eagle Hunter Solutions Limited challenging the action of the State government in entrusting the work of operation...

and maintenance of mobile medical units infrastructure and to provide primary and selective secondary healthcare under '104' services to the respondent Piramal Institute.
The petitioner's counsel contended that the offer made by the respondent institute was a conditional offer since it sought for reimbursement of capital expenditure and the said condition was withdrawn only on the request...

made by the then tender committee last year, which is illegal.
On the other hand, the government counsel submitted that the evaluation of the tender was made in a transparent manner and hence no interference is needed in selecting the respondent institute for rendering the service. In fact, the petitioner took back the EMD amount and was not entitled to file the present case and challenge the issuance...

of letter of intent in favour of the respondent company he argued.
After hearing the case and perusing the material on record, the judge found that there was no record with the government in connection with the present case. As there was no government order enabling the commissioner of Health and Family Welfare to enter into a service agreement and take consequential proceedings, the actions taken by him are...

without any authority of law, the judge held. While allowing the petition, Justice Ramalingeswara Rao directed the government to issue a fresh notification for inviting tenders for the said services and select the agency by constituting an appropriate tender committee consisting of members representing the state, commissioners of health and finance departments and NTR Vaidya Sava Trusts.

Naidu unveils ₹1.66 lakh crore bank credit plan for 2017-18 fiscal

CHIEF Minister N Chandrababu Naidu on Friday unveiled the State Credit Plan amounting to ₹1,66,000 crore for the 2017-18 fiscal. The credit plan is 14.6 per cent more when compared to the previous year's credit plan.

During the State-level Bankers' Committee (SLBC) with the Interim Government Complex in Velappudi on Friday, the Chief Minister sought the support of bankers for the development of the State.
Stating that the government is giving utmost priority to the agriculture sector, he wanted the bankers to extend cooperation to implement reforms in the sector for doubling the income of farmers.

Saying that preference has been given to horticulture, livestock and other allied sectors, Naidu appealed to the bankers to lend loans liberally to farmers as well as tenants on time.
Asserting that the government is focusing more on development of MSMEs, Naidu wanted the bankers to give loans to MSMEs.

Stating that the cooperation of bankers is crucial for the development of the State, he said a committee would be formed with representatives from government and bankers and that would hold a review meeting with bankers once in every 10 days starting from June 28. When the bankers raised the issue of the land owners availing crop loan and at the same time, tenant farmers approaching banks for loans with Loan Eligibility Cards or Certificate of Cultivation (CoCs), the CM said to ensure accountability in lending loans, Online Beneficiary Management and Monitoring System (OB-MMS) should be implemented.
