He further informed that inspite of hiccups such as introduction of Excise duty and the strike by jewelers at the beginning of the year and demonetization towards in the third quarter the Company has been able to achieve better results for the financial year ended 31.03.2017.

He also highlighted that the company is working out better strategy for the growth of the business and has plans to expand the retail business in the current financial year 2017-18 and would achieve better performance by synergizing the operations of the retail business.


